the Company reserving the right to withhold the prize if so advised by these judges.

The score must be presented anonymously and clearly marked with a motto and be accompanied by a sealed envelope bearing the same motto and enclosing the name and address of the Composer.

The copyright of the winning Composition will remain with the Composer but the Company reserves the right of first performance of the work and to retain the Manuscript submitted.

Only the name of the successful competitor will be published. The Manuscripts of other competitors will be returned by the Clerk if so requested.
